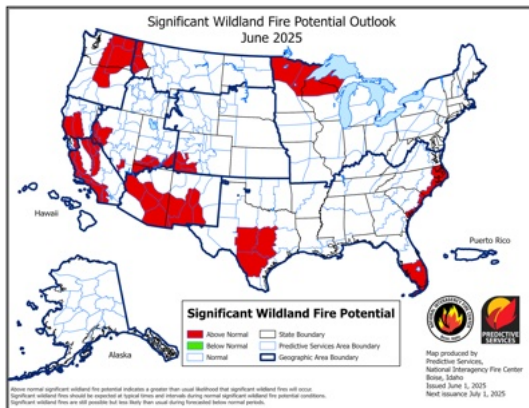

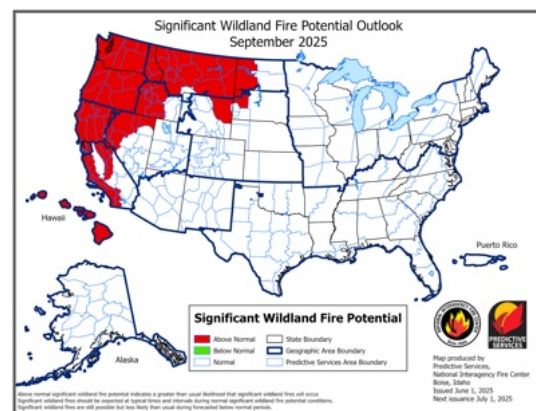

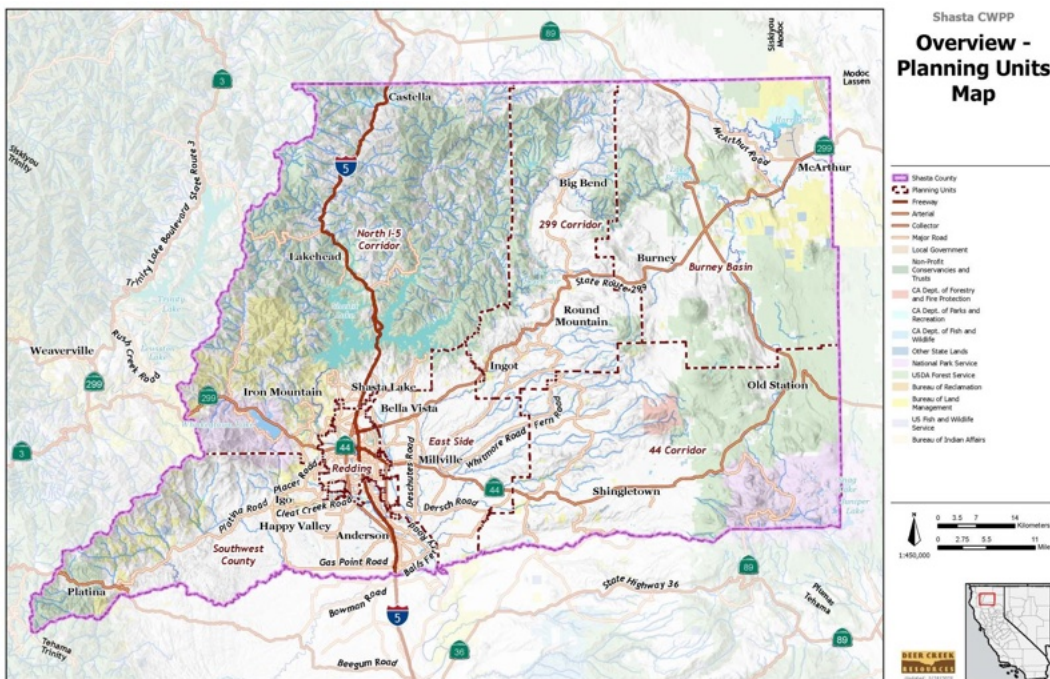

## Wildfire Risk: What to Expect This Summer

The 2025 National Significant Wildland Fire Potential Outlook warns of above-normal potential for significant wildfires in California and other western states this summer. Based on historical patterns and current conditions, we can expect 1 to 3 large fires in June, with the number likely to increase to 1 to 4 large fires during July and August. With hotter, drier weather and persistent fuel buildup, communities in fire-prone areas must [stay alert](#) and [take action now](#) to reduce risk.

Make sure your property is defensible, your evacuation plans are up to date, and your neighborhood is connected with the [Fire Safe Council](#) and [Firewise USA®](#) programs.



## Draft Maps for the Shasta Community Wildfire Protection Plan

## 2024/2025 Chipper Season



## Thanks to You, Our First Free Chipping Season Was a Success!

The Shasta County Fire Safe Council wrapped up its first no-cost chipper service for the 2024–2025 season, helping hundreds of residents reduce hazardous fuels and create safer, more defensible space around their homes. The program followed a regional schedule, beginning in October on the east side and finishing in June in Shingletown. [It will return in October 2025 with the same rotation.](#)

- Total residences who scheduled chipping services (through June): **234**
  - Cubic yards of vegetation chipped (through May): **3,115**
  - Estimated acres treated (through May): **222.5**
